BALLOT INITIATIVE COMMITTEE: MILL LEVY REPORT

IX. NEW BUSINESS

MILL LEVY <u>ELECTION DISCUSSION AND POSSIBLE BOARD ACTION</u>

Ms. McIntyre informed the board that Mr. Graybill, from Graybill Law Firm, reached out with concerns regarding the upcoming election. He would like to represent the library. Ms. McIntyre informed us that the City Manager would not object if the Library obtained outside council.

Ms. Bulger made of a motion that the Great Falls Library Board of Trustees retain Graybill Law Firm for outside council in regards to the Mill Levy Election. Ms. DeForest seconded the motion. Ms. Olson opened for any board discussion or public comment. Ms. Crist recused herself due to Mr. Graybill being her son. Ms. Olson called for a vote. Motion passed with 3 votes in favor, and 1 abstention.
